President's report- Katie Clark

National Landscape Architecture Month- Brian Staresnick

- Estimate of \$3,500 for the entire month

 - o Focus on First Friday events- allow members to submit works research etc. and have it placed in a gallery. Many people already attend these events so the traffic is already there.

Chapter Public Relations- Brian Staresnick

- Estimate of \$6,000 (this has a big cushion because we don't know what to expect yet depending on how much Dean is contributing, and how much other sponsors like Home Depot donate)
 - o Snacks/Water/Lunch for volunteers
 - o Event t-shirts for volunteers
 - o Inexpensive work gloves, tools (maybe a few shovels, or hammers? hopefully we can get these donated, but I'm throwing it in here just in case)
- Outside the Box- Empower people with disabilities
 - Looking to transform their outdoor space into a sensory garden. Brian and Dean have worked out a schedule- possibly construct the end of April. Would be two weekends to construct. We can cross promote NLAM and the Year of Public Service.
 - o The group has funds to pay for the materials etc. as well as connections to get materials etc. The group is very excited to begin work.
 - o Dean Hill- is trying to get a film crew together to film the process and the construction. We would at least have a final film to use for marketing etc.
 - o Possibly have a CEU opportunity related to Sensory gardens.
- Schedule hinges on Dean Hill's travel to Indiana
 - o April 27th construction
 - o March 9th- final design done
 - February 23- design charrette- mostly with the staff and the leadership and 3 5 of their clients. Film crew will be there to document the process.
- We could ask for sponsorships to help offset the budget amount for INASLA.
- Brian will get with Glenn to put together an email blast for registrations.
